The Lithonia Lighting® brand supports The Buy America(n) Act, strengthening U.S. manufacturing. We back this effort in many of our key products by producing them in the U.S. and using domestically sourced materials. We call out this effort in our products by using “BAA” (Buy America(n) Act) either directly in our catalog numbers or referenced in our spec sheets. It’s not always easy to understand regulations and procurement procedures, so we have developed this Quick Reference Guide to help identify our Buy America(n) compliant product offering.

Several types of Buy America(n) legislations exist, and our BAA meets all five of the most common regulations for federal domestic procurements. For additional details on these regulations, check out the [Buy America\(n\) Guidance](#) link. When trade agreements

apply, even more Acuity products can be supplied and treated the same as a domestic U.S. product for purposes of applying U.S. procurement laws.
